### Qualifications

To qualify, your facility must:

- Be in the SCE service area (direct access OK)
- Have a peak load greater than 200 kW

### Technical Support

EnergyConnect provides the technical support to develop curtailment strategies, enroll your facility, manage your participation and guarantee your payments. You can now participate in demand response with minimal impact on operations.

### Limited Call Hours

The program runs year round. Call hours are between 11 AM and 5 PM. You will never be asked to reduce power for more than 50 hours annually.

### Flexible Participation

You control your monthly level of participation. The more power you are willing to reduce, the more you will earn.

### Event Notifications

Reduction notifications are sent via e-mail, pager, and telephone message. Several notifications are provided:

- Firm notice by 3 PM the day prior to the event
- All-clear notice at the end of the event and restoration of normal operations
- Optional direct interface to automated controls

## How Much Can You Earn?

You control your payments depending on how much you are willing to reduce and how well you perform (see table). By reviewing your power consumption and operational flexibility, we can more clearly define your levels of compensation.

Committed Energy Reduction	Annual Payment Range
2000 kW	\$144,000–\$96,000
1000 kW	\$72,000–\$48,000
500 kW	\$36,000–\$24,000
250 kW	\$18,000–\$12,000

### Payments

Get paid for year round participation:

#### Standby Payments

- Earn monthly standby payments just for being ready to reduce power

#### Bonus Payments

- Earn an annual bonus for meeting 90% of your reduction potential

#### Payment for every kWh of energy reduced

- Get paid a premium for your kWh reduced
- Get an excess energy payment: 3X premium for any additional kWh you reduce

### What kinds of loads qualify?

Any load that exceeds 200 kW and can be reduced at least 100 kW is eligible. Examples of reduction strategies include:

Air-conditioning and chillers	Heavy machinery
Electric furnaces and heaters	Industrial air handling
Plug loads	Battery chargers
Agricultural and municipal pumping	Industrial freezers or warehouse cooling
Mineral and mining equipment	Water treatment and aeration
Metal forming and shaping processes	Lighting and non-critical loads of any kind

## Participation FAQs

### What if I can't participate when I am called?

Reliable participation is critical to this program. We develop a curtailment strategy that ensures minimal impact on business operations, worker safety and comfort. We understand business needs evolve; we can adapt your curtailment plan to acceptable levels. Participants get paid for every kW reduced.

### Are there costs, risks or penalties?

None. There are no costs to get started and no financial risks to participate. As our customer, EnergyConnect pays you... you don't pay us!

### How does demand response support my company's green initiatives?

Your participation in demand response delivers added benefits. It improves the reliability and efficiency of the electrical grid, decreases the need for new power generation, makes environmental stewardship profitable, helps prevent rolling blackouts and brownouts, and ultimately reduces your facility's carbon footprint.

### Is this an SCE program?

The program is provided through a direct contract with SCE and is approved and monitored by the California Public Utilities Commission. The program is an alternative to the recently mandated default Critical Peak Pricing (CPP) tariff for commercial/industrial customers. Customers registering in the Share the Power program are exempt from the high rate structure imposed during CPP events.

### How do I get started?

Getting started is easy. At the initial meeting, we help you understand the program, its parameters, and how it will achieve your financial and sustainability goals. If temporary load reductions are viable, you can start earning immediately. A simple enrollment agreement with no risk ensures you have the flexibility to participate on your terms and provides the opportunities to adjust participation level if needed.
